### **Inhalation.**

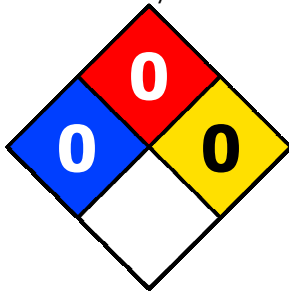
