### Eye contact.

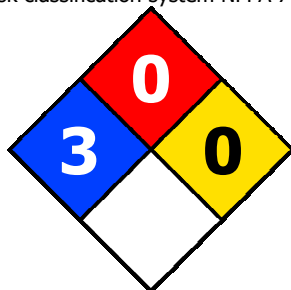
