Ingestion.

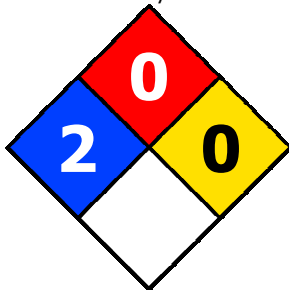
