Inhalation.

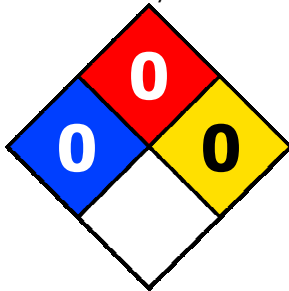
