Skin contact.

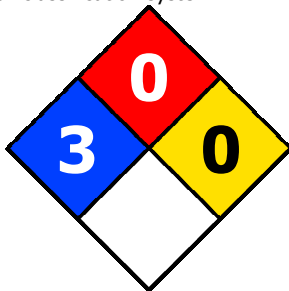
