### 5.1 Extinguishing media.

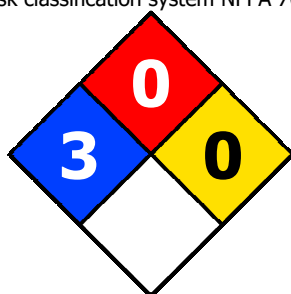
